THE MINISTER OF AGROAND RURAL INDUSTRIES (SHRI MAHABIR PRASAD): (a) The State-wise details of educated unemployed youth provided employment under the Prime Minister's Rozgar Yojana (PMRY) during the last two years, i.e., 2002-03 and 2003-04 are given in Statement-I. (See below)

- (b) The State-wise details of funds (including Tamil Nadu) released for entrepreneurial development training, contingencies, etc., during the last two years, i.e, 2002-03 and 2003-04 under the PMRY are given in Statement II, (See below). In addition, the Central funds for subsidy are routed through the Reserve Bank of India (RBI) which, in turn, passes them on to the implementing banks for crediting the amounts to the loan accounts of individual beneficiaries.
- (c) The measures taken by the Government to make the scheme more effective include enhancing the eligible upper age limit and subsidy ceiling for applicants in the hilly States of Uttaranchal, Himachal Pradesh and Jammu & Kashmir (in addition to States in the North Eastern Region), circulating to States/Union Territories (UTs) restructured curricula and methodology of training for the PMRY beneficiaries, instructions to the implementing agencies/banks to dispose of applications received within specified time limits, reiterating quarterly schedule for completing the activities of sponsoring cases and sanctioning/disbursing loans to ensure achievements of targets by the end of the financial year itself, etc.
