Employees' Pension Scheme, 1995 had been constituted by the Central Government for overall review of the Employees' Pension Scheme, 1995. In this process an Expert Committee was constituted under the Chairmanship of Additional Secretary (Labour and Employment) for reviewing the Employees' Pension Scheme, 1995. The Expert Committee has submitted its report to the Central Government on 05.08.2010, which is under consideration. The Expert Committee has also deliberated on the issue of increase in pension.

#### Employment generation schemes in Andhra Pradesh

3209. SHRIMATI GUNDU SUDHARANI: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

(a) to what extent the employment generation schemes are helping in reducing the unemployment in the country, particularly in Andhra Pradesh;

(b) whether it is a fact that Eleventh Plan aims to create 58 million job opportunities; and

(c) if so, the details thereof and the achievement in the first three years of the Eleventh Plan?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI HARISH RAWAT): (a) Government of India is implementing various employment generation programmes in both rural and urban areas across the country including Andhra Pradesh to Increase employment opportunities, such as, Swarnjayanti Gram Swarozgar Yojana (SGSY); Swarna Jayanti Shahari Rozgar Yojana (SJSRY); Prime Minister's Employment Generation Programme (PMEGP) and Mahatama Gandhi National Rural Employment Guarantee Act (MGNREGA). SGSY has been restructured as the National Rural Livelihood Mission to make it universal in application, focused in approach and time bound for poverty eradication by 2014-2015. Progress of employment generation under special employment generation and poverty alleviation programmes during the first three years of the Eleventh Plan and the current year for all India and Andhra Pradesh is given in Statement-I (*See* below).

(b) Yes, Sir. Eleventh Five Year Plan aims at creating 58 million new job opportunities.

(c) Sector-wise details of 58 million new job opportunities are given in Statement-II (*See* below). Reliable estimates of employment and unemployment are based on the quinquennial labour force surveys conducted by National Sample Survey Organization. Last such survey was conducted during 2009-10 (July-June) and the results are likely to become available during 2011.
