

**Container Terminal in Chennai**

3843. SHRIMATI S.G. INDIRA: Will the Minister of SHIPPING, ROAD TRANSPORT AND HIGHWAYS be pleased to state:

(a) whether it is a fact that Government had given in principle approval for the development of a second container terminal in Chennai Port;

(b) if so, the details thereof;

(c) whether it is also a fact that the said project would be implemented on Built-Operate-Transfer (BOT) basis; and

(d) whether it is also a fact that the proposed terminal capacity would be sealable to six lakh TEUs (Twenty-foot equivalent units) from the second year of operation?

THE MINISTER OF SHIPPING, ROAD TRANSPORT AND HIGHWAYS (SHRI T.R. BAALU): (a) to (d) In-principle approval has been conveyed by Government of India on 31.3.2005 for the development of second container terminal in Chennai Port at the modernized East Quay and the adjoining South Quay-III berths, with quay length of 826m and backup area of 28 hectares. The proposed container terminal, to be developed on Build, Operate and Transfer (BOT) basis, is estimated to cost Rs. 491 crore with a capacity to handle 6 lakhs twenty-foot equivalent units (TEUs) per annum from the second year of operation. The Port is expected to contribute Rs. 100 crore for developmental works. Notice inviting Request for Qualification has been issued on 16.4.2005 and the last date for submission of applications is 20.6.2005

**Condition of NH-31**

(a) whether Government are aware of the fact that condition of National Highways No. 31 between Pasraha and Narayanpur remain dilapidated due to which the water of Kosi and Ganga get clogged between National Highways No. 31 and railway line causing soil to become wet and get spread and deteriorating the road everyday;

(b) if so, whether Government propose to improve the condition of the said Highways soon;

(c) if so, by when; and

**THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING, ROAD TRANSPORT AND HIGHWAYS (SHRI K.H. MUNIYAPPA):** (a) Yes, Sir.

(b) to (d) Bhakhtiyarpur-Purnea Section of National Highways No. 31, which includes Pasraha-Narayanpur portion, is proposed for upgradation under National Highways Development Project (Phase-III) by National Highways authority of India for which the preparation of Detailed Project Report is under progress. Therefore, it is too early to comment on the execution of civil construction works on the aforesaid portion of National Highway No. 31. However, an estimate amounting to Rs. 290.88 Lakhs has been sanctioned in March, 2005, which includes repair of this Section.

### **Ship acquisition programme**

**3845. SHRI R.P. GOENKA:** Will the Minister of SHIPPING, ROAD TRANSPORT AND HIGHWAYS be pleased to state:

(a) whether it is a fact that the Shipping Corporation of India has drawn up a \$500 million ship acquisition programme;

(b) if so, the details thereof;

(c) whether it is a fact that the shipyards, the world over, are not able to accept fresh orders for new vessels till 2007 and the Shipping Corporation of India may have to wait for its expansion plan till then or explore other ways, amongst others, to pick up second-hand vessels or opt for chartering them; and

(d) if so, the details of the fresh strategy drawn up to augment the fleet capacity?

**THE MINISTER OF SHIPPING, ROAD TRANSPORT AND HIGHWAYS (SHRI T.R. BAALU):** (a) and (b) Shipping Corporation of India (SCI) has proposed acquisition of 18 vessels at a total estimated investment of about US\$ 800 million, as per details given below:
