Funds are released by the Central Government to the States based on the labour demand arising at the field level. Funds released by the Centre and utilized by the State of Bihar during 2008-09, 2009-10 and 2010-11 (till date) are as under:

- (b) As per reports available from the State Government of Bihar, a cumulative total of 1,09,07,050 job cards have been issued under Mahatma Gandhi NREGA in Bihar up to September, 2010.
- (c) Para 4 of Schedule-II of Mahatma Gandhi NREGA stipulates that every adult member of a registered household whose name appears in the job card shall be entitled to apply for unskilled manual work under the scheme. Under the Act, mere issuance of a job card does not entitle a household to receive employment. The household holding a Job Card has to, under Para 9 of Schedule II of the Act, submit application for work to be entitled to receive employment. Therefore, the number of days of employment provided has to be seen against the number of Households who were provided employment. Among the households provided employment, the number of households who completed 100 days of employment during 2008-09, 2009-10 and 2010-11 (up to September, 2010) is as under:
