- (a) the details of projects proposals sent and financial assistance demanded by the State Government of Madhya Pradesh under Pradhan Mantri Gram Sadak Yojana (PMGSY); and
- (b) the quantum of amount sanctioned to the State under this programme during the last three years?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI PRADEEP JAIN): (a) All the proposals submitted by Madhya Pradesh under PMGSY upto 2009-10, satisfying the programme guidelines and various instructions issued by the Ministry, have been conveyed clearance. Further, the funds are released to States keeping in view the requirement of funds, the absorption capacity and as per provisions of the programme guidelines. Upto September 2010, project proposals valued at Rs. 13,280 crore for construction of 12,271 road works have been cleared under PMGSY against which Rs. 9,410 crore has been released to Madhya Pradesh.

(b) The funds released to Madhya Pradesh during last three years under PMGSY is as follows:

## Status of TSC in Uttar Pradesh

- (b) the number of villages of Uttar Pradesh where TSC has been implemented, districtwise;
  - (c) the total number of toilets provided so far under TSC in Uttar Pradesh;
- (d) whether Government proposes to cover all the villages in the State under TSC within a time frame;
  - (e) the details thereof; and
  - (f) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (KUMARI AGATHA SANGMA): (a) The Government of India administers the Total Sanitation Campaign (TSC), a comprehensive programme started in the year, 1999 to ensure sanitation facilities in rural areas with the main goal of eradicating the practice of open defecation and ensuring clean environment. The main components are incentive for Individual Household Latrines (IHHL), School Sanitation and Hygiene Education (SSHE), assistance for Community Sanitary Complex, Anganwadi toilets and Solid and Liquid Waste Management; (SLWM). Total Sanitation Campaign is a demand driven, project based programme taking district as a unit. There are 607 district projects approved in the country till date.

- (b) TSC is being implemented in all 71 districts of Uttar Pradesh as per the project proposals received and all Gram Panchayats requiring improvement in sanitation facilities are supposed to be covered through the District projects.
- (c) Total 1,33,82,568 toilets (for BPLs and APLs) in rural areas of Uttar Pradesh have been reported to be constructed as per the progress reported by the State through on line monitoring system maintained by the Department as on 30th October, 2010.
- (d) to (f) Yes, Sir. Sanitation coverage in rural areas of the State of Uttar Pradesh as on 30.10.10 is 71.85% as per the progress reported by the State. As mentioned above TSC is a demand driven, project based campaign. It is expected that with the demand generated through effective Information Education and Communication (IEC) coupled with fund availability, all the Gram Panchayats of Uttar Pradesh shall be covered under TSC with 100% sanitation coverage by 2015.
