Seats reserved for Physically Handicapped students in Universities

3505. SHRI N.K.SINGH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) the number and percentage of seats reserved for Physically Handicapped students that were left vacant for the academic year 2010-11 in each Central University;
- (b) whether there is a provision for converting such vacant seats into general category seats; and
- (c) the steps taken by Government to make the University campuses more disabled friendly?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI D. PURANDESWARI): (a) and (b) As per Section 39 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995, three percent reservation in admission to various courses in Central Universities is applicable and the reservation is made horizontally in each category. In the Act there is no provision for converting vacant seats reserved for Physically Handicapped (PH) into general category seats. Since the relevant information for the academic year 2010-11 is not readily available, on the basis of the information furnished by the University Grants Commission, the details indicating, University-wise, students enrolment, number of PH category students enrolled and their percentage against the overall enrolment, as on 31.3.2010, is given in the Statement (See below).

(c) Universities are providing necessary facilities to Physically Handicapped students, *interalia*, disabled friendly toilets, ramps and lifts. The University Grants Commission in their XI Plan Guidelines for General Development Assistance to Universities have advised the Universities to furnish a certificate to the effect that the estimates of the building project include provision for ramps and toilets on the ground floor in the buildings wherever necessary to enable the use of the building for the differently abled (physically challenged) persons.
