Installation of automatic door closures in trains

- (a) whether Government is considering any proposal to install automatic door closing system in all trains to prevent mishaps on running trains on the pattern of Metro trains;
 - (b) if so, the details thereof;
 - (c) if not, the reasons therefor;
- (d) whether Government has made any time-bound programme for installing automatic door closing system in all trains; and
 - (e) if so, details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI E. AHAMMED): (a) to (e) The matter is under consideration.

Rail projects in Tamil Nadu

3532. SHRI PAUL MANOJ PANDIAN: Will the Minister of RAILWAYS be pleased to state:

- (a) the pending railway projects pertaining to Tirunelveli and Tuticorin districts of Tamil Nadu; and
 - (b) whether the projects will be included in the forthcoming budget in public interest?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI E. AHAMMED): (a) and (b) Gauge conversion of Tirunelveli-Tenkasi metre gauge line, falling in the district of Tirunelveli, is

already sanctioned as a part of Quilon-Tirunelveli-Trichendur and Tenkasi-Virudhunagar gauge conversion project Gauge conversion of this section is targeted for completion during 2010-11.

Proposal for construction of Madurai-Tuticorin new line passing through Tuticorin District is being processed for requisite clearances.

Infrastructural facilities for stations in Tamil Nadu

3533. SHRI PAUL MANOJ PANDIAN: Will the Minister of RAILWAYS be pleased to state:

- (a) whether steps will be taken by Government to provide infrastructure facilities for the Palyamkottai railway station, Tirunelveli district and Armuganeri railway station, Tuticorin district, Tamil Nadu on an urgent basis; and
 - (b) whether necessary funds will be allocated in the budget?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI E. AHAMMED): (a) and (b) Palayamkottai and Armuganeri are 'E' category railway stations and they have been provided with amenities as per norms commensurate with present level of traffic. In addition, works pertaining to construction of platform fencing and toilet have been taken up at Palayamkottai station. Similarly, works pertaining to extension of Platform No.I to hold 24 coaches at Armuganeri station have been taken up. Necessary funds are available to carry out these works.

Hiring of out agencies

- (a) when was the current Railway Out Agency engaged in carriage of various Railway goods from Jammu Tawi Railway Station to different destinations in J&K first hired by the Railways for this purpose;

- (c) the number of agencies/companies participated in such bids/tenders for this particular job, when the current Out Agency was hired?
