(c) whether the CAG is investigating into the allotment of 2G spectrum by the Ministry and issuance of licences given to new companies in the year 2008; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI SACHIN PILOT): (a) and (b) Sir, Director General Audit, Post & Telecommunications (DG Audit, P&T) in September, 2010 had suggested that any decision taken on the proposed exit route for some telecom licensees and allotment of spectrum to merged entities should be in consonance with the terms and conditions of the licence agreements and as per the laid down policy on mergers and acquisition. National interest and financial angles should be given priority.

(c) and (d) On 19.07.2010, DG Audit, P&T issued a Draft Performance Audit Report on "the issue of licences and allocation of 2G Spectrum by Department of Telecommunications (DoT)" for comments of DoT. The DoT on 27.07.10 and 31.08.2010 has made available its detailed reply to the DG Audit, P&T.

Laboratory for security issues of telecom sector

A Pilot Test laboratory at Indian Institute of Science (IISc), Bangalore for processes, procedures and tests for testing vulnerabilities & malwares in Telecom Equipment has been set up.

- (c) Consultation with Ministry of Home Affairs is done on need basis.
- (d) Equipments are proposed to be tested against vulnerabilities and malwares in the equipment.
