†419. SHRI RAGHUNANDAN SHARMA: Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) the details of amount given as grant during the last five years, Non-Government Organisation-wise and State-wise, whether disbursement is made in ratio of number of institution for disabled person or population of the State or number of poor households;
- (b) if not whether Government would formulate any policy/rule so that all States or their Non-Government organizations may be provided suitable fund for welfare of disabled persons; and
- (c) by when the District Disability Rehabilitation Centres, which are presently operating in 17 districts only, would be opened in each of the districts and whether the Rehabilitation Centres are insufficient in view of 14 lakh population of disabled persons?

THE MINISTER OF STATE IN THE MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT (SHRI D. NAPOLEON): (a) and (b) The position of release of grant-in-aid under the different Schemes of the Ministry of Social Justice & Empowerment for Persons with Disabilities is given below:

- (i) Assistance to Disabled Persons for Purchase/Fitting of Aids and Appliances (ADIP): Details of amount given to NGOs during the last 5 years, State wise is given in the Statement-I (See below). Since 2007-08 the disbursement of the funds is made on the basis of the district-wise National Allocation which is based on the percentage of disabled in each district.
- (ii) Scheme for Implementation of the Persons with disabilities act, 1995 (SIPDA): This Ministry has been implementing a Scheme of providing financial assistance for undertaking activities in pursuance of the PwD Act. The scheme is known as the "Scheme for Implementation of Persons with Disabilities Act, 1995 (SIPDA)". Assistance under SIPDA is provided for non-recurring purposes.
 - From this year the system of Notional Allocation broadly based on the population of Persons with Disabilities has been introduced. The details of allocation of funds to the State Governments under the scheme for the last five years is given in the Statement-II (See below).
- (iii) Deendayal Disabled Rehabilitation Scheme (DDRS): Allocation of funds under the Deendayal Disabled Rehabilitation Scheme (DDRS) to various States of the Country is made on the basis of proportionate disabled population of the State and accordingly the funds are released to the Non-Governmental Organizations of the concerned State. The details of State-wise release of grants to the Non Governmental Organizations under Deendayal Disabled Rehabilitation Scheme during the last five years is given in the Statement III (See below).

(c) Presently, there are 199 Approved District Disability Rehabilitation Centres (DDRC) in various districts of the Country. Apart from this, Government has decided to set up 100 new DDRCs during the Eleventh Five Year Plan, out of which, 50 are proposed to be set up in the current financial year.
