

(a) the provision in the law to prevent exploitation of Indian children after their adoption by foreigners, at present;

(b) whether Government has been receiving complaints against improper upbringing of such adopted children;

(c) whether the Supreme Court has also suggested Government that a proper effective law should be made regarding adoption of Indian children by foreigners to avoid their possible exploitation; and

(d) if so, by when Government would make a law in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI KRISHNA TIRATH): (a) Central Adoption Resource Authority (CARA) guidelines on Inter-country Adoption 2006 provide for post adoption follow-up by foreign agencies enlisted by CARA and Central Authorities of foreign countries, as a safeguard for Indian children adopted by foreigners.

(b) No, Sir.

(c) Government of India has not received any order of the Hon'ble Supreme Court of India to this effect.

(d) The Government of India has initiated steps for framing an Implementing Legislation on Hague Convention on Inter-country Adoption, 1993.

#### **Setting up of shelter homes**

772. DR. JANARDHAN WAGHMARE: Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

(a) whether Government proposes to set up shelter homes/widow homes in the country;

(b) if so, the details thereof, State-wise; and

(c) the funds sanctioned, released and utilized by Government during the last three years and the current year, State-wise?

THE MINISTER OF STATE OF THE MINISTRY OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI KRISHNA TIRATH): (a) and (b) Government of India in the Ministry of Women and Child Development is implementing two shelter based schemes *i.e.* Swadhar and Short Stay Home for women/girls in difficult circumstances. The State-wise number of shelter homes functioning in the country is given in Statement-I (See below).

(c) State-wise details of funds sanctioned and released during last three years and current year is given in the Statement-II (See below). Funds released to the implementing agencies are utilized by them and the unutilized amount, if any, is adjusted towards subsequent installment of grant.
