Drought assistance to Maharashtra

- 3881. SHRI TARIQ ANWAR: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether it is a fact that farmers of Maharashtra who have been hit by the drought have not been paid enough compensation;;
 - (b) if so, the reasons therefor;
 - (c) whether the farmers are facing acute starvation;
- (d) whether the State Government had sought relief from the Central Government; and
 - (e) if so, the response of the Central Government?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI KANTILAL BHURIA): (a) to (e) No report has been received in the Ministry of Agriculture from the Government of Maharashtra regarding farmers in the State facing acute starvation. On the basis of final paisewari, the State Government has declared 25 districts as drought affected.

In response to the Memorandum submitted by the State Government recently, seeking assistance of Rs. 988.37 crores from National Calamity Contingency Fund (NCCF) and 2 lakh MTs of foodgrains for drought relief employment, an Inter-Ministerial Central Team has visited the State for assessment of the situation. Further action will be taken on receipt of the Team's report, in accordance with the prescribed procedure.

Setting up of Maize Production Industry in Khagaria and Bhagalpur

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI KANTI LAL BHURIA): (a) The weighted average cost of production -of Maize for 2002-03 has been estimated at Rs. 329.34 per quintal and Rs. 421.39 per quintal for Khagaria and Bhagalpur districts respectively. As against this, the Minimum Support Price (MSP) of Maize crop for 2002-03 was Rs. 485.00 per quintal (excluding Rs. 5.00 per quintal announced as special drought relief price). Thus MSP was higher than the cost production in both the districts. The prevailing market prices of maize in Bihar are ruling above MSP of Rs. 525.00 per quintal announced for the Kharif crop of 2004-05 season.

(b) to (d) Government does not propose to set up maize processing industry in those areas. However, Central Government in the Ministry of Food Processing Industries provide financial assistance in the form of Grant-in-Aid @ 25% and 33.33% of the project cost subject to maximum of Rs. 50.00 lakhs and Rs. 75.00 lakhs in general areas and difficult areas respectively to all implementing agencies to set up food processing units.
