- (c) and (d) The Ministry has received 180 complaints relating to corruption in the implementation of MGNREGA and 39 complaints regarding leakage of funds through bank and post office accounts.
- (e) At the time of launch of Mahatma Gandhi NREGA, payment of wages to workers was to be made in cash. However, *vide* notification dated 19.2.2009, payment of wages has been made mandatory through worker's accounts in banks/post offices.
