- (a) the number of blocks in Jharkhand having 30 bed Community Health Centres (CHCs);
 - (b) the staff strength in these block CHCs;
- (c) the number of blocks which do not have CHC at all, along with the medical staff and medicines; and
- (d) by when National Rural Health Mission (NRHM) norms including physical infrastructure and medical human resource will be met and proper CHC will be established in all 259 blocks in Jharkhand?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI GHULAM NABI AZAD): (a) to (d) As per the information received from Government of Jharkhand, there is no block in Jharkhand having 30-beded Community Health Centre (CHC). However, there are 188 blocks having 6 bedded Community Health Centres. Other blocks do not have CHC. Construction of CHCs have been taken up in 144 blocks. There are 2001 Medical Officers and 8415 Paramedical Staff posted in the health facilities.

Under National Rural Health Mission [NRHM], funds are provided to Government of Jharkhand to strengthen their health infrastructure at all levels including CHCs. The State Government prioritises the requirements and incorporate them in its annual Programme Implementation Plans (PIPs) which is a continuous process. The same is examined in this Ministry and funds are released to the State for actual implementation of the programme in accordance with approved PIP.

Financial assistance to States for controlling population

- (a) whether it is a fact that States have been granted financial assistance of Rs. 2930.31 crore for controlling population during 2007-08, 2008-09 and 2009-10;
- (b) whether it is also a fact that despite spending heavy amount each year, the progress so far has not been satisfactory towards achievement of target of population stabilization; and
- (c) if so, the reasons for not taking more concrete steps for achieving the targets of stabilization?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI GHULAM NABI AZAD): (a) Yes. Financial assistance of Rs.2930.31 crore has been granted for various measures aimed at controlling population during 2007-08, 2008-09 and 2009-10 at per details are given in Statement (*See* below).

(b) Population Stabilization measures have been implemented with varying degree of success across different States of the country.
