## Cancer treatment machine at GMCH, Chandigarh

868. SHRI AVINASH RAI KHANNA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that Rs. 2 crore worth cancer treatment machine installed in Government Medical College and Hospital (GMCH), Chandigarh is gathering dust;
  - (b) the steps Government is taking to put in operation that machine; and
  - (c) what action has taken against the erring officials?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI S. GANDHISELVAN): (a) Government Medical College and Hospital (GMCH), Chandigarh have installed a cancer machine which was received free of cost from Society of Applied Microwave Electronics Engineering and Research (SAMEER), a Research and Development Laboratory under Union Ministry of Information Technology, Government of India. At present the machine is non-functional.

- (b) GMCH, Chandigarh is entering into an agreement with SAMEER to make this machine functional.
- (c) No employee of GMCH can be held responsible as the machine was procured by SAMEER and given to the Institute free of cost.
