- (a) the total area of agricultural land as on date across the country, particularly in Rajasthan;
  - (b) the area of land that can be made arable; and
  - (c) whether serious efforts are being made by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (PROF. K.V. THOMAS): (a) to (c) As per the available estimates, total agricultural land/arable land is 182.44 million ha. in the country, which includes 25.58 million ha. of arable land of the Rajasthan State. The barren and unculturable lands are located in isolated blocks or within cultivated holdings which includes all land covered by mountains, deserts, etc. is about 17.29 million ha. in the country. Such lands can only be brought partly under cultivation at an exorbitant cost, therefore, Government of India, Ministry of Agriculture does not promote any comprehensive scheme/programme to develop barren lands for agricultural purposes.

## Availability of rakes for transportation of fertilizers

(c) to (f) Ministry of Railways has been providing sufficient number of rakes for transportation of fertilizers to Madhya Pradesh. As a result, the cumulative availability of Urea, DAP & MOP during the year 2010-11 (April'10 to October'10) has been maintained over and above the assessed demand as under:
