- (b) The base construction cost of the Project including cost of land acquisition is estimated at Rs. 50761 crores. This exclude escalation, contingency, PPP element, taxes and interest during construction.
- (c) No, Sir. Under Section 20 F of the Railways (Amendment) Act, 2008 award has been made for over 20% of land to be acquired for the project. The total land requirement for the project is, however, under review with the intention of bringing the proposed alignment as close to the existing rail track as possible.
 - (d) Does not arise.

Construction of railway crossing bridge

†1200. SHRI RANBBR SINGH PARJAPATI: Will the Minister of RAILWAYS be pleased to state:

- (a) the criterion for construction of railway crossing bridge;
- (b) whether it is based on public demand; if so, the reasons for pending of sanction of railway crossing bridge in Jind district of Haryana for last 30 years and also the reasons for construction of four railway crossing bridges in Rohtak district of Haryana, recently in a short time span of some months; and
- (c) the details of number of crossing over bridges pending for construction in Haryana so far?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI E. AHAMMED): (a) Railway crossing bridges, i.e., Road Over Bridges (ROB) in lieu of level crossings are constructed on cost sharing basis, if Train Vehicle Unit (TVU) of the level crossing is one lakh or above, subject to State Govt's consent for closing of level crossings, 50:50 cost sharing, provision of funds in their Budget, advance action for arrangement of encumbrances free land acquisition, shifting of utilities, etc; otherwise, on Deposit or Build Operate Transfer basis, where cost of construction of ROB is fully borne by the sponsoring agency.

(b) Yes Sir. Public demands, routed through the State Govts, are also taken in cognizance. Such proposals are examined in light of above criterion and depending upon the feasibility, a decision is taken in the individual cases. All such cases where TVUs are less than mandated TVUs, are however taken up on Deposit terms. All level crossing gates, of Jind District of Haryana, qualifying for ROB, have already been sanctioned.
