Train accident - free modern technology

- (b) if so, the details thereof by indicating which new and modern technologies are available for the railway safety; and
- (c) whether Government has fixed any time-frame for the implementation of train accident-free modern technology throughout the country?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI E. AHAMMED): (a) Yes, Sir.

- (b) The important modern technologies and measures available for railway safety are given below:
 - (i) Train Protection Warning System (TPWS)
 - (ii) Anti Collision Device (ACD)
 - (iii) Vigilance Control Device (VCD)
 - (iv) Wheel Impact Load Detectors (WILD)
 - (v) Provision of twinbeam headlights and flasher lights in locomotives.
 - (vi) Use of Fire retardant, electric cable in locos & passenger coaches.

- (vii) Provision of emergency light with separate battery back up in all new main line coaches.
- (viii) Mobile Train Radio Communication (MTRC)
- (ix) Manning of all unmanned level crossing gates.
- (c) Inducting new technologies for safe and reliable train operations is a continuous process. The proliferation of these systems on the entire railway network shall be considered on successful completion of the trials in phases as early as possible.

Gauge conversion of Udaipur-Ahmedabad line

- (a) whether it is a fact that in the year 2008, Government had approved gauge conversion from metre gauge to broad gauge on Udaipur to Ahmedabad line;
