1468.SHRI R.C. SINGH: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that the incidences of Malaria infection in India is on the rise;
- (b) if so, the details thereof;
- (c) whether it is also a fact that deaths due to malaria is also on the rise;
- (d) if so, the details thereof for the past three years, State-wise;
- (e) whether Government had taken any specific programme to bring down both the infection and deaths due to Malaria;
 - (f) if so, the details thereof; and
 - (g) if not, the reasons therefor?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI GHULAM NABI AZAD): (a) and (b) No. The number of reported malaria cases in the country during 2007-09 has by and large remained static with minor fluctuations.

- (c) and (d) Number of reported deaths due to malaria have come down from 1311 deaths in 2007 to 1144 deaths in 2009. The number of reported cases and deaths due to malaria during past three years, State-wise is given in Statement (See below).
- (e) and (f) For prevention and control of vector-borne diseases including malaria, Government of India is implementing an integrated National Vector Borne Disease Control Programame (NVBDCP) under the overarching umbrella of National Rural Health Mission (NRHM). The main strategy for prevention and control of vector-borne diseases advocates for integrated vector control, early case detection and complete treatment, and behavior change communication. Government of India provides technical support and also supplements the efforts of States/UTs by providing funds and commodities as per their project implementation plans under NRHM. However, the programme is primarily being implemented through the State/UT Governments.
