THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI E. AHAMMED): (a) and (b) Insects were reported in coach E-1 (Executive Chair Car) of Kalka-New Delhi Shatabdi Express train, which arrived New Delhi on 08.11.2010.

- (d) The contractor for Pest and Rodent Control treatment in this train has been penalized. Disciplinary action has been initiated against the concerned staff responsible for maintenance and upkeep of air conditioners in this coach.

Professional agencies are being engaged for Pest and Rodent control and cleaning activities in Trains. Checks/Inspections in these areas and Maintenance of passenger amenities shall be intensified.
