Proposal to upgrade primary and secondary schools

*258. SHRI NATUJI HALAJI THAKOR: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether there is a proposal to upgrade primary and secondary schools throughout the country;

(b) if so, the details thereof alongwith the present status of the proposal, State-wise; and

(c) the amount likely to be spent under this programme?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI KAPIL SIBAL): (a) to (c) With the enforcement of the Right of Children to Free and Compulsory Education (RTE) Act, 2009, the norms for opening of schools under Sarva Shiksha Abhiyan (SSA) programme have been revised to provide for primary and upper primary schools within such area of limits of neighbourhood as notified by the States/UTs under the State RTE Rules. Till 31.3.2010, 1,62,017 upper primary schools have been sanctioned under SSA. For the year 2010-11, Central budget support of Rs. 19,000 crore is available for implementation of SSA programme by the States/Union Territories.

The Centrally sponsored scheme of Rashtriya Madhyamik Shiksha Abhiyan

(RMSA), envisages opening of new secondary schools and upgradation of upper primary schools to the secondary stage. 2478 new secondary schools were sanctioned in 2009-10 under RMSA. An amount of Rs. 978.16 crore has been released to the States under RMSA for implementation of Annual Plan proposals for 2009-10. The budget provision for 2010-11 is Rs. 1700 crore.
