- (c) the details of amount requested by the State Government of Uttar Pradesh under this scheme for allotment; and
 - (d) the length of road in rural areas that would be constructed to connect villages, thereby?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI PRADEEP JAIN): (a) and (b) Uttar Pradesh has been released Rs. 2,348.89 crore under Phase-VII of Pradhan Mantri Gram Sadak Yojana (PMGSY). Out of this Rs. 938.00 crore has been released in the current financial year 2010-11.

- (c) Funds under PMGSY are released to States depending upon their demand, absorption capacity, works undertaken and fulfilling of certain conditions laid down in the programme guidelines for release of funds. So far Rs. 9,513.93 crore has been released to the State Government since, inception of the programme.
- (d) The project proposals for construction of 41,945 km. of road length for providing connectivity to 11,367 habitations have been sanctioned to Uttar Pradesh under PMGSY upto September, 2010. Against the target of 8,011 km. of road length proposed under the Phase-VII, 6,804 km. length of road works have been completed till September, 2010.

Construction of school toilet units in Uttar Pradesh

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (MS. AGATHA SANGMA): (a) to (c) The Government of India administers the Total Sanitation Campaign (TSC), a comprehensive programme started in the year 1999 to ensure sanitation facilities in rural areas with the main objective of eradicating the practice of open defecation and ensuring clean environment. TSC is demand driven, project based programme taking district as a unit. The School Sanitation and

Hygiene Education (SSHE) is an integral component of the programme wherein central assistance is provided for provision of toilet units in all types of Government Schools which do not have toilet facilities. The details of total number of school toilet units approved and reported to be constructed as per progress reported by the State through online monitoring system maintained by the Department of Drinking Water and Sanitation (DDWS) in rural areas of Uttar Pradesh with Central assistance under TSC, district-wise is given in Statement (See below). The present objective is of covering all Government Schools with toilet facility under TSC by March, 2012.
