HAULING OF MANGALORE-MADRAS MAIL BY DIESEL ENGINE

-441. SHRI B. V. ABDULLA KOYA: Will the Minister of RAILWAYS be pleased to state :

(a) whether Government have received any representation from the people of North-Kerala requesting the hauling of Mangalore-Madras Mail by diesel engine in order to speed up the Mail train and also for hauling more bogies; and

(b) if so, the action taken by Government in the matter ?

THE MINISTER OF RAILWAYS (SHRI T. A. PAI) : (a) Yes, Sir.

(b) Dieselisation of long distance overcrowded Mail/Express trains is being done on a programmed basis having regard to the limited availability of diesel locomotives which are primarily required for clearance of goods traffic. As awl when additional diesel locomotives become available, dieselisation of 1 Dn/2 Up Madras-Mangalore Mail will be duly considered alongwith other similar demands.

PASSENGER TRAFFIC

1175. SHRI SANAT KUMAR RAHA : Will the Minister of RAILWAYS be pleased to state the extent of passenger traffic in 1971 and so far during the year 1972 ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI) : Statistics are maintained for financial years. During 1971-72. Passenger traffic in terms of passengers originating amounted to 2.536 millions and in terms of passenger Kilometres 125.333 millions. The corresponding figures for 1970-71 were 2,431 millions and 118.120 millions respectively.

In the current year, the approximate number of passengers booked during the period April to October 1972 were 1,539 million[^] as against 1,429 millions in the corresponding period of 1971-72.
