- (c) The scheme envisages the production of 12,000 vehicles p^{*r} annum. The terms of collaboration cannot be divulged.

MANUFACTURE OF CHEAP AND GOOD QUALITY TV SETS

- 1367. SHRIMATI SAVITA BEHEN: Will the PRIME MINISTER be pleased to slate:
- (a) whether in view of the fact that by the end of the 4th Five Year Plan as many as nine TV stations are likely to be commissioned to cover almost the entire length and breadth of the country, what special efforts have been and are being made to manufacture cheap and good quality TV receiving sets to bring TV facility within the reach of the common man and the progress made so far in this regard, both in the private sector and the public sector: and the minimum price at which a set can now be prepared within the country; and
- (b) the present total installed capacity of TV receiving sets, in the private sector, small scale, large scale and cooperative ventures and in the public sector; and the targets fixed in this regard for the 4th Five Year Plan?

THE MINISTER OF ELECTRONICS (SHRI K. C. PANT); (a) TV sets currently being manufactured in the country are of good quality and comparable with foreign made TV sets.

Generally speaking, a TV set even at internationally • competitive prices, is a high-priced item and thus is not within the reach of large numbers in India for private purchase. It is hoped to cover a large audience through the use of community receivers.

To bring down the prices of TV sets some of the important steps being implemented are given below:—

(i) Gradual reduction in the prices of electronic components by setting up

- large volume production; components account for a substantial portion of the *e-ost* of TV sets; in particular. Government is considering ways of bringing down the prices of the TV picture tube which is the largest single item;
- (ii) larger quantity production of TV sets, so that the supply is adequate for the demand; approvals have been given to a large number of parlies, particularly i in the small scale sector, and it is hoped that there will be sufficient commercial competition;
 - (iii) production of transistorised TV sets;
 - (iv) through the introduction of TV sets with small screens; there are technical/marketing aspects relating to small TV tubes/screens which are under examination and decision will be taken shortly.

At present the ex-factory price of $19" \mid TV$ set is about Rs. 1600.

(b) The present total approved capacity of TV sets in the small scale and organized (both private and public) sectors and i cooperative ventures is over 2.8 lakh sets j per annum. The target fixed in this re-| gard by AIR for the 4th Five Year Plan! was estimated at 2 lakh sets per annum.

Total additional employment expected to be generated during the period is of the order of 1.5 million persons. The proposal has been forwarded to the Planning Commission for further action.
