EVASION OF EXCISE DUTY BY HAND-OPE-RATED TEXTILE PROCESSING UNITS

Will the Minister of FINANCE be pleased to state:

- (a) whether Government have seen press reports regarding large-scale evasion of excise duty by hand-operated textile processing units; and
- (b) the number of hand-operated textile units registered with the excise authorities and their capacity and excise duty collected from them for the years 1970-71 and 1971-72?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI K. R. GANESH): (a) One press report in the Economic Times of 12th August, 1972 has come to Government's notice alleging avoidance of processing duty

by art silk mills by making wrong submission that their products are handprocessed. Inquiries so far made in regard to this allegation show that it is not correct. If, however, any specific instance is brought to the notice of the Government necessary action will be taken.

(b) Art silk fabrics processed without the aid of power or steam, in other words hand-processed, are exempt from whole of the Central Excise duty leviable thereon, and therefore, the question of duty being realised in respect of such fabrics does not arise.

Units undertaking such hand-processing are not required to take out Central Excise licence, and therefore, information regarding their capacity is not available.
