Will the Minister of FOREIGN TRADE be pleased to state:

(a) whether any negotiations have taken place with the European Eco-nomic Community for safeguarding Indian export interest after the im-pending enlargement of the Community, if so, the details in this regard and the latest position with regard to these negotiations;

(b) whether the British Government have assured of their assistance in seeking approval of the Council of Ministers of the Community for the conclusion of a commercial co-operation agreement between India and the Economic Community; and

(c) whether a five-year non-preferential trade agreement with India has been proposed by the Common Market Executive Commission, if so, the details thereof and Government's reaction thereto?

THE MINISTER OF FOREIGN TRADE (SHRI L. N. MISRA): (a) Negotiations are still continuing both with the U.K. and EEC for safeguarding India's trade interests in the context of U.K.'s entry into EEC.

(b) The British Government have indicated to us of their support in principle regarding India's proposal for a commercial cooperation Agreement with the European Economic Community.

(c) The matter is still under examination of the competent authorities of the Community.
