SHORTAGE OF RAW MATERIAL

- 1581. SHRI U. K. LAKSHMANA GOWDA: Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state:
- (a) whether there is an acute shortage of raw material required by the Small Scale Industries in the State of Mysore;
- (b) if so, the number of Small Scale Industries which are closed for want of raw material in that State, and what steps are being taken by Government to meet this shortage?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOPMENT (PROF. SIDDHESHWAR PRASAD): (a) There is a general shortage of certain raw materials in the country which is being experienced by actual users including those in the State of Mysore.

(b) Information regarding number of small scale industries which are closed for want of raw materials is being collected.

Efforts are being continuously made to enhance the allocation of raw materials for small scale industries depending upon their availability.

REQUEST FROM STATES FOR RECASTING AID FORMULA

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA): (a) Yes, Sir.

(b) No modification in the existing criteria for allocation of Central assistance to States as approved by N.D.C. is contemplated during the Fourth Five Year Plan. In relation to the Fifth Five Year Plan, a view has yet to be taken on the principles which should govern Central assistance to States.

SALE OF PLOTS IN BADLI INDUSTRIAL ESTATE

1586. SHRI GANESHI LAL CHAU-DHARY: Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state:

- (a) whether Government are aware that physical possession of plots to about 20/25 allottees in the Badli Industrial Estate, Delhi, has not so far been given to them even though the total cost of the plots was paid in 1968-69 and the lease deeds therefor were executed by them in 1970;
- (b) whether it is a fact that such allottees were asked of middle 1971 to deposit extra money for the cost of the land on the plea that the area of their allotted plots was found more on actual measurement;
- (c) whether it is also a fact that the extra amount of additional land was not accepted when the concerned allottees approached the authorities in 1971 itself; and
- (d) the steps Government proposes to take for enabling such allottees to deposit the extra amount for the additional land and for getting the possession of the plots handed over to the concerned allottees?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVE-LOPMENT (PROF. **SIDDHESHWAR** PRASAD): (a) Physical possession of plots to 28 allottees has not been given as the total cost of plots is yet to be paid fully by them.

(b) The allottees were asked to pay for additional expenses on development charges and cost of area which was found to be excess on measurement.

- (c) Delhi Administration has no such information
- (d) Possession will be given after full payment is made by the allottees and after fulfilment of other requirements.

SMALL INDUSTRIAL ESTATE AT NARELA, **DELHI**

- (a) whether Government propose acquire land at Narela in Delhi for setting up of a small industrial estate:

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVE-LOPMENT (PROF. **SIDDHESHWAR** PRASAD): (a) and (b) Yes, Sir. Delhi Development Authority has earmarked an area of 534.2 acres for industrial use. The industrial estate is proposed to be set up on an area of 300 acres.

(c) It is proposed to give priority to applicants from rural areas of Delhi. Date for inviting applications has not been decided.
