YADAV): (a) and (b) While in the working of this Akademi, as in the case of similar other institutions and organizations, there is always room for improvement, it would not be correct to make the sweeping statement that the Akademi has altogether failed to fulfil its objectives.

- (d) All art forms are given adequate attention within the resources available to the Akademi, Classified accounts for each of the three art forms separately, however, are not maintained.
- (e) A statement giving the information is attached.

## STATEMENT

The specific contributions of the Sangeet Natak Akademi for the development of music, dance and drama.

- (i) Organising art festivals, seminars and exhibitions on music, dance and drama at Delhi and other centres.
- (ii) Distribution of annual awards to eminent artistes in the fields of music, dance and drama. For the last five years the occassion has been turned into a 7-day festival of arts featuring the award-winning artistes.

- (lii) Publication of important works on music, dance and drama in English and other Ind an languages, besides a quality quarterly journal; also giving subsidy to the authors and publishers for bringing out publications on these subjects;
- (iv) Building up a tape music library of classical, folk, tribal and ritual music; and collection of photographs and colour slides.
- (v) Documentation of traditional arts through films, slides and photographs covering all the traditional art forms of different regions.
- (vi) Supporting training programmes in the fields of music, dance and drama by giving financial assistance to some of the major institutions in the country.
- (vii) Running three training institutions for imparting training in dance and drama namely, the Kathak Kendra, Jawaharlal Nehru Manipur Dance Academy and the National School of Drama and Asian Theatre Institute
