**RURAL EMPLOYMENT CRASH SCHEME
IN MYSORE STATE**

210 SHRI H. S. NARASIAH : Will the Minister of AGRICULTURE be pleased to state :

(a) how much of money was allotted to the Mysore State under the Rural Employment Crash Scheme, which came into operation last year ;

(b) how many lakhs man-days are generated under its operation in the State of Mysore ; and

(c) how much of the allotted amount was spent ?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (PROF. SHER SINGH) : (a) A sum of Rs. 237.50 lakhs was allotted to Mysore State under the Crash Scheme for Rural Employment for each of the years 1971-72 and 1972-73.

(b) and (c) According to the reports received from the State Government a sum of Rs. 152.13 lakhs was spent during 1971-72 resulting in the generation of 38.01 lakh mandays of employment. In the year 1972-73 upto August, 1972, a sum of Rs. 39.76 lakh is reported to have been spent resulting in the generation of 11.95 lakh mandays of employment.

**SETTING UP OF A COMMITTEE TO INQUIRE

A comprehensive report of India's participation in the Munich Olympics has been submitted by the official delegation and Government is considering the matter, in consultation with the All India Council of Sports for introducing remedial measures.
