THEFT OF PLATINUM FROM URANIUM LABORATORY AT JADUGUOA

Will the Minister of ATOMIC ENERGY be pleased to state :

(a) whether it is a fact that platinum worth Rs. 9 lakhs has recently been stolen from the Uranium Laboratory at Jaduguda near Jamshedpur ; and

(b) if so, what are the details of the case, and what preventive steps are being taken in this regard ?]

प्रधान मंत्री और परमाणु ऊर्जा मंत्री (श्रीमती इन्दिरा गांधी) : (क) और (ख) जदुगुडा स्थित यूरेनियम कारपोरेशन ऑफ इंडिया लिमिटेड के अनुसंधान एवं विकास विभाग के नियन्त्रक की ताला लगी तिजोरी से 14 अगस्त, 1972 के सायं 5 बजे तक तथा 16 अगस्त, 1972 के प्रातः 7 बजे के मध्य लगभग 50,000 रुपये की कीमत के प्लेटिनम के पात्र (क़ुसिबल, ढक्कन, प्लेटें आदि) चोरी हो गए। स्थानीय पुलिस को इस चोरी की रिपोर्ट दर्ज कराई जा चुकी है तथा तहकीकात जारी है। इस बीच, कम्पनी में सुरक्षा-व्यवस्था को सुधारने के लिए कदम उठाये जा चुके हैं।

[THE PRIME MINISTER AND MINISTER OF ATOMIC ENERGY (SHRI-MATI INDIRA GANGHI) : (a) and (b) Platinum ware (crucibles, lids, dishes etc.) valued at roughly Rs. 50,000 were stolen from a locked safe of the Control, Research and Development Department of Uranium Corporation of India Ltd., Jadu-guda, between 5.00 p. m. on 14 August, 1972 and 7.00 a.m. on 16th August, 1972. A case of theft has been lodged with the local police and investigations are in progress. Meanwhile, steps have been taken to improve security arrangements within the Company.]

TELEVISION CENTRE AT RANCHI

364. SHRI B. R. MUNDA : Will the Minister of INFORMATION AND BROADCASTING be pleased to state :

(a) whether there is any proposal under Government's consideration to establish a Television Centre at Ranchi ;

(b) whether it is a fact that the Television Centre, when established at Ranchi, will also serve the masses of Bokaro, Jamshedpur, Chaibasa, Hazaribagh, Daltong ganj and other industrial towns of Chota-nagpur ;

(c) whether it is also a fact that the people belonging to Scheduled Tribes, Scheduled Castes and other backward classes residing in these towns will be largely benefitted by the television centre ; and

(d) if the answer to part (a) above be in the affirmative, the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINHA) : (a) to (d) No, Sir. There is no such proposal at present under consideration.

It is, however proposed to cover progressively and in a phased manner, the entire country with the TV network.

AGREEMENT FOR DISTRIBUTING SOVIET NEWS IN INDIA

365. SHRI BANARSI DAS : Will the Minister of INFORMATION AND BROADCASTING be pleased to state :

(a) whether it is a fact that the United News of India has entered into an agreement with Soviet News Agency Tass for distributing Soviet News in India ; and

(b) if so, what is the financial benefit that the UNI is likely to get by this agreement ?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINHA) : (a) Yes, Sir.

(b) UNI have requested that since the arrangements between UNI and TASS are commercial in nature, it would not be appropriate to make them public.

OMISSION OF TAMIL CITATION IN THE TAMRA PATRAS

366. SHRI V.V. SWAMINATHAN : Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether it is a fact that Tamra Patras awarded to Freedom Fighters do not contain citation in Tamil and other regional languages mentioned in the VIII Schedule of the Constitution except in the official language ; and

(b) whether it is a fact that the Freedom Fighters were not properly treated during Silver Jubilee Celebrations in the Capital ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K.C. PANT) : (a) Yes, Sir. But translations of the text in regional languages were printed and published to the recipients along with the tamra patras.

(b) No Sir. Adequate facilities were provided to the freedom fighters.
