THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOP-MENT (PROF. SIDDHESHWAR PRASAD): (a) The Indian Standard Wagon Company are manufacturers of Railway Wagons, Steel Structurals, Steel Forgings and Springs. Production has been low as against the rated capacity though decline in actual production from year to year has been limited to structurals. Production of railway wagons has also fallen sharply in 1972.

(b) and (c) The question of investigation into the affairs of the Company under the provisions of Industries (Development and Regulation) Act, 1951 is under consideration.
