THE MINISTER OF DEFENCE (SHRI JAGJIVAN RAM): (a) and (b) Government are aware of the press report. Although there are reports about the possibility of China test firing an ICBM over the Indian sub-continent into the Indian ocean, there is no authentic information about this.

#### INDIANS' ENTRY INTO BRITAIN

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) Some harassment is being faced by people going from India to Britain at the hands of immigration officials of the U.K.

(b) Government have taken up the matter with the British authorities on a number of occasions and hope that, as a result of their demarches, treatment accorded to visitors from India on arrival at ports of entry in the UK would improve.

#### APPLICATIONS FOR GRANT OF LICENCES FOR MINI STEEL PLANTS

(a) whether it is a fact that 120 applications have been received for the grant of licences for the mini-steel plants; and

(b) if so, the reaction of Government regarding the grant of licences?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI SHAH NAWAZ KHAN):

(a) and (b) 120 applications, including some which were rejected earlier, for setting up of small scale units for the manufacture of steel ingots/billets in electric furnaces are being examined, keeping in view the need to encourage dispersal of the industry: preference to public sector/ joint sector units, units going to backward districts, and to the smaller entrepreneurs; economic scale of production and similar factors.
