The University has not yet submitted the relevant amendment to the Ordinance to the Visitor.

L.I.G. FLATS CONSTRUCTED BY D.D.A.

1745. CHAUDHARY A. MOHAMMAD: Will the Minister of WORKS AND HOUSING AND HEALTH AND FAMILY PLANNING be pleased to state:

(a) whether Government have received any Memorandum from the residents of LIG flats built by the DDA which are badly constructed and are costly too; and if so, what are the main issues that have been raised therein; and

(b) whether Government have considered the points raised in the Memorandum; and if so, what action is proposed to be taken thereon?

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING (PROF. DEBIPRASAD CHATTOPADHYAY):

(a) Yes, Sir. Sometime back the Lawrance Road Welfare Association forwarded to the Ministry, copies of the Memorandum addressed by them to the Delhi Development Authority. The main issues raised by them are regarding the cost of the flat, structural defects in the flats and request of provision of another set of flats in the place of the existing ones.

(b) The points raised in the Memorandum are being examined by the Delhi Development Authority.

P.H.M. OF PROVIDENT FUND TO THE RETIRED SCHOOL PRINCIPALS

1746. SHRI JAGAN NATH BHARDWAJ: Will the MINISTER OF EDUCATION AND SOCIAL WELFARE be pleased to state:

(a) whether it is a fact that a few Principals of Government Higher Secondary

Schools in Delhi, who have retired in March 1972 have not yet been paid their Provident Fund and gratuity;

(b) if so, the names of such Principals and the dates on which they have retired and the reasons for which payments have not been made to them;

(c) what steps are being taken in the matter to make immediate payment to these Principals; and

(d) the action taken or proposed to be taken against the persons responsible for the delay?

1111 DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SOCIAL WELFARE AND IN THE DEPARTMENT OF CULTURE (SHRI D. P. YADAV): (a) to (c) Only one Principal, Shri R. K. Aggarwal, working at Gandhi Memorial Higher Secondary School Shahdara, retired on 9-3-72. Although his relieving orders were issued by the Delhi Administration on 1-4-1972, Shri Aggarwal did not hand over the charge of the school till 29-3-1972. On this account the payment of Provident Fund and gratuity could not be finalised. The matter is under consideration of the Delhi Administration.
