TAKING OF LIQUOR BY AN OFFICER OF B.A.R.C. IN OFFICE PREMISES

THE PRIME MINISTER AND MINISTER OF ATOMIC ENERGY (SHRIMATI INDIRA GANDHI): (a) A private party financed by contributions from the participants was held in the officers' mess of the Bhabha Atomic Research Centre, Trombay on June 21, 1972 to felicitate an officer of the Centre on his appointment as a Director. Alcoholic refreshments were served at this party. The participants possessed valid permits for the consumption of liquor and hence did not violate any law in force in the area.

COLLECTION OF SALT CESS IN STATES

(a) the amount of salt cess collected from Maluwa, Bhavnagar, Jafraabad, Bherai and Victor from 1968 to 1972, year-wise;

(b) whether the cess so collected has been spent for the object for which it has been levied and collected; if so, the details thereof;

(c) the total collection of this cess for the year from 1968 to 1972 for the Saurashtra area and the details of the expenditure incurred for the object for which it has been collected; and

(d) the details of the demand placed by the Government of Gujarat for utilisation of this salt cess fund; work-wise and programme-wise?

The incidence of cess collected from the salt works is ultimately passed on to consumers who are spread all over the country. The proceeds of cess collected are credited to the General Revenues of the Government of India. These are utilised, after deducting the cost of collection as determined by the Central Government, if Parliament by appropriation made by law in this behalf so provides, on all or any of the following objects, namely:

(a) meeting the expenditure incurred in connection with the salt organisation maintained by the Central Government;

(b) meeting the cost of measures taken in connection with the manufacture, supply and distribution of salt by Union agencies and the regulation and control of the manufac-

ture, supply and distribution of salt by other agencies; and in particular, measures for—

(i) the establishment and maintenance of research stations and model salt farms;

(ii) the establishment, maintenance and expansion of salt factories;

(iii) fixing the grades of salt;

(iv) promoting and encouraging cooperative effort among manufacturers of salt; and

(v) promoting the welfare of labour employed in the salt industry.
