(b) The natural outlet for Assam tea is the port of Calcutta but a part of this tea started moving through Kandla during the last few years, due to certain difficulties in warehousing at Calcutta and the damage/pilferage resulting from the transshipments involved. The position has changed considerably due to the opening of the new rail cum-road bridge over Farakka Tea traffic through Kandla has, therefore, declined.
