(b) whether Government have received any report in this regard from the Delhi University ;

(c) if so, the details thereof; and

(d) whether a seminar was held in New Delhi recently on 'Drug, Abuse by Youth' and any recommendations were made by it and if so, the reaction of Government thereto ?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN) : (a) to (c) The University has not received any specific complaint in this regard. The Delhi School of Social Work has, however, recently conducted a small exploratory study on Students and Drugs in Delhi University. The report seeks to provide some information in regard students of Delhi University who use various types of addicted drugs. It does not give any indication of the size of drug taking "population. A copy of the report has been forwarded by the University to the Government!.

(d) An Inter-Disciplinary Seminar on "Drug Abuse and Youth" was organised by the Directorate of Social Welfare, Delhi Administration on July 28, 1972. The recommendations of the Seminar (as given in the attached statement) are being considered by the Administration.

#### STATEMENT

#### RECOMMENDATIONS

(1) Since no reliable Statistics about the youth involved in drug addiction are available, a research study of the problem may be taken up to identify, in the Indian context, causes and dimensions of the problem in rural urban, non-student and student youth.

(2) The size of the problem may not be alarming but it has definitely inbuilt potentials for which a concerted preventive programme be taken up in co-operation with the Departments of Education, Health and Family Welfare emphasising family responsibility towards children. Action should be taken at individual and social levels and the approach be muhipronged.

(3) While legal action should be taken against drug pedlars, the drug addicts be treated in special wards of general hospitals duly equipped with psychiatric and other services for de-addiction of drug addiction.

(4) Concerted legal and other action be ensured to check clandestine cultivation, illicit manufacture, leakage through adulteration, black market in distribution, and unethical medical prescription, which are responsible for the present situation, by strengthening the enforcement agencies by technical aids and coordination among concerned authorities.

(5) The mass media should be geared up so as to become effective in alienating human thought. It should not be used for describing the thrills but for explaining the phenomenon and informing the community of the consequences of drug abuse.

(6) An inter-disciplinary committee composed of representatives from -hefields of health, education and social welfare and of police and the public be set up by the Administration to work as an advisory and policy making body in the matter of prevention of drug addiction and control.

(7) Recreation and other extra-curricular activities be organised not only in the schools but also in the neighbourhoods so that both the student and non-student youth may utilise their leisure properly.

(8) The production of harmful drugs, which are likely to be misused, may be taken in public sector and its production be regulated.
