THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA) : (a) and (b) Yes. A Preliminary Report of the Action Group to review the Power Supply Position in West Bengal has been received and the same is under examination in the Planning Commission.

IMPOSITION OF RENT CONTROL ACT IN UNION TERRITORIES

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN) : (a) and (b) The Government of India received representations from traders, associations, individuals and Chandigarh Administration for the imposition of rent restriction laws in Chandigarh. A Notification applying the provisions of the East Punjab Urban Rent Restriction Act, 1949, to Chandigarh was issued on the 13th October, 1972.
