THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI MOHAN DHARIA): (a) and (b) Yes, Sir. The salient points of this document are indicated in the note attached. [See Appendix LXXXII, Annexure No. 30]

SOLUTION FOR IMPLEMENTATION OF INDUSTRIAL LICENCES

674. SHRI A. G. KULKARNI: SHRI S. B. BOBDEY: SHRI V. R. PARASHAR:

Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state:

(a) what steps are being taken for the speedy implementation of industrial licences and whether his Ministry has proposed a package approach to solve various troubles due to lengthy Licensing Procedure; and

(b) how many licences and Letters of Intent have been granted in 1971-72 and what is, the present backlog of the licence applications?

THE DEPUTY MINISTER IN THE INDUSTRIAL DEVE-MINISTRY OF SIDDHESHWAR LOPMENT (PROF. PRASAD): (a) It has been observed that, in practice, the setting up of an industrial undertaking and commencement of production therein takes about 3 to 4 years' time from the issue of a letter of intent. The progress made by holders of industrial licences is reviewed, as a matter of course, at the stage of considering applications the period for the extension of for implementation of licences and an increasingly selective approach is being adopted for granting such requests. In cases where it has been found that negligible interest has been taken in implementation, warnings have been issued or a final extension given and, in appropriate cases, licences revoked or cancelled. The progress made by certain categories of holders of licences such as the State Industrial Development Corporation and those relating to certain selected, important items of manufacture such as Calcium automobile tyres and tubes, selected electronics items, caustic soda, soda ash has been reviewed. As a result of such selected reviews, some general bottlenecks standing in the way of speedy implementation have been identified and steps are being taken to remedy the situation to the extent possible. Government are considering the introduction of a system for a centralised, continuous of implementation with a computerised information system regarding, inter-alia, progress in the implementation of industrial licences. Government have taken several steps to streamline the procedure for consideration of applications for industrial licences such as periodical reviews senior levels, imposition of time limits for action at various stages; automatic consideration of pending applications after expiry of certain time limits,

etc. As a result of this the disposal of these applications has been speeded up. The matter is kept under constant review.

(b) Between 1st January, 1971 and 30th September, 1972, a total of 1681 letters of intent and 1036 industrial licences have bean granted and as on 1st October, 1972, a total of 1827 applications for industrial licences were pending.
