THE MINISTER OF STATE (DEFENCE PRODUCTION) IN THE MINISTRY OF DEFENCE (SHRI VIDYA CHARAN SHUKLA): (a) and (b) HAL have started progressive manufacture of SA-315 helicopters The manufacture of this helicopter has been taken up under a licence agreement with SNIAS of France, to meet the requirements of Armed Forces for Air Observation Posts duties.

## SIGNING A TREATY OF FRIEND-SHIP WITH THE UNITED STATES

809. SHRI U. K. LAKSHMANA GOWDA: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that the Finance Minister made a statement in Washington at the National Press Club to the effect that India was ready to sign a treaty of friendship with the United States; and
- (b) the reaction of the U.S. Government thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) Replying to a question on this subject at the National Press Club in Washington on September 27 the Finance Minister indicated Government's willingness to sign a treaty of friendship with any country on the basis of mutuality of interests. He went on to imply that at the present moment the question of concluding such a treaty between India and the United States is not engaging the attention of either government.

STRIKE BY COLLIERY WORKERS IN ASANSOL

- (a) whether it is a fact that over 3000 colliery workers from the Sirpur and Rana Colliery in Asansol in West Bengal have gone on a wild-cat strike since October 22, 1972;

- (c) what steps are being taken to meet the demands of the workers?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI R. K. KHADIL-KAR): (a) About 2700 workers of Rana Colliery and 634 workers of Sripur Seam Inc-

line Colliery resorted to strike w. e. f. 22nd October, 1972 and 1.10.72 respectively.

- (b) The strike was in protest against introduction of seven day work in the Colliery by the Management.
- (c) As a result of intervention by C. I. R. M., settlements have been reached on both the cases on 1.11.72 and 6.10.72 respectively.
