(b) and (c) During the initial years of operation, losses in projects of the size and type of HEG do arise on account of the Heavy investments and long gestation periods. To a certain extent, the losses can be attributed to slow build-up of production due to a combination of factors including deficiencies in management over these years and unsatisfactory industrial relations; the heavy burden of interest, depreciation and overheads have also contributed to the losses.

A number of steps have been and are being taken over a wide front to improve material management and production control, implement objective-oriented programmes and improve efficiency of management and productivity of workers. A Task Force has also been set up in the Ministry to review the performance of the Corporation at regular intervals. This has helped in identification of problems impeding production.

As a result of these measures, the performance of Heavy Engineering Corporation has shown a significant improvement during 1971-72 and is expected to improve considerably during the next two years.

INDO-PAK TALKS

757. SHRI BHUPESH GUPTA : SHRI SITARAM KESRI : SHRI THILLAI VILLALAN : SHRI K. A. KRISHNASWAMY :

Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether it is a fact that Prime Minister ruled out the possibility of a summit meeting with Mr. Bhutto in the near future ;

(b) if so, what are the reasons therefor ;

(c) whether negotiations are going on between the two Governments to draw the final line of control in Kashmir ; and

(d) what are the results of the negotiations ?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) and (b) Further talks at the summit level between India and Pakistan depend on the full implementation of paragraphs 4 and 3 of Simla Agreement and Delhi Agreement, respectively, and, in particular, on the delineation of the line of control in Tammu and Kashmir resulting from the cease-fire of December 17, 1971 along its entire length.

(c) and (d) A full statement on the negotiations for delineating the line of control in Tammu & Kashmir has already been made by the Minister of External Affairs in the House on 14th November, 1972.

COMPULSORY INSURANCE FOR ARMED FORCES PERSONNEL

758. SHRI O. P. TYAGI: Will the Minister of DEFENCE be pleased to state :

(a) whether Government propose to bring all the officers and jawans of the armed forces under the Compulsory Insurance Scheme financed by Government so that they may be able to settle themselves well at the time of retirement from the service ; and

(b) if not, the reasons therefor ?

THE MINISTER OF DEFENCE (SHRI JAGJIVAN RAM) : (a) and (b) No, Sir. There is no such proposal under examination of Government. However, a draft scheme named "Army Insurance-cum-Savings Fund" for officers and personnel of the Army has been received by Government recently for consideration.

t [NAMING OF ARMY UNITS

759. SHRI O. P. TYAGI : Will the Minister of DEFENCE be pleased to state :

(a) the reasons for naming the army units on the basis of caste and province in a secular and non-communal country like India;

(b) whether Government propose to do away with the said system ; and

(c) if not, the reasons therefor ?]

रक्षा मंत्री (श्री जगजीवन राम) : (क) से (ग) सरकार सेना में वर्ग-भेद के पक्ष में नहीं है और वर्ग, जाति अथवा क्षेत्र विशेष के आधार पर किसी नई रेजिमेंट को नाम देने की इच्छा नहीं रखती है। तथापि पुराने समय में कुछ सैनिक यूनिटों के नाम जाति/क्षेत्र विशेष से सम्बन्धित रहे हैं। इस सम्बन्ध के मुख्य कारण ऐतिहासिक हैं। पुराने नामों को केवल बदलने से कोई विशेष लाभ होने की आशा नहीं है।

f[THE MINISTER OF DEFENCE (SHRI JAGJIVAN RAM) : (a) to (c) Government are not in favour of any class distinctions in Army and do not intend to name any new regiments on the basis of class, caste or region. In the past, however, some army units have had their names associated with caste/region. The reasons for this association have been mainly historical. No particular purpose is likely to be served by merely changing the old names.]

t [PRESS RELEASE OF THE INDO-PAK TALKS

(a) whether Government are aware that all the news and information regarding the talks with the Pakistan President held at Simla and the Indo-Pak talks held at New Delhi were broadcast by and published in Pakistan and other foreign radio and press before their broadcast by the All India Radio and publication by the Indian Press ; and

(b) if so, the reasons for such indifference shown to the Indian information media ?]

(ख) कुछ मामलों में निषेध की शर्तों का हमारे अखबारों एवं प्रचार माध्यमों द्वारा निष्ठा से पालन किए जाने के फलस्वरूप कुछ खबरें अन्यत्र पहले प्रकाशित हो गई थीं। भारतीय अखबार या भारत सरकार की उदासीनता के कारण ऐसा नहीं हुआ है।
