RAILWAY LINES WITHIN SUNDARBANS

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MOHD. SHAFI QURESHI): Due to paucity of funds and inadequate traffic justification and high cost of the suggested lines in the difficult terrain, it will not be possible to consider these projects in the Sundarbans at present.
