COAL SUPPLY TO DESU

(a) whether it is a fact that the private agencies supplying coal to Delhi Electric Supply Undertaking stopped their supply and that the coal now being supplied by Government agencies is not upto the mark besides being costlier and

(b) if so what steps Government have taken to improve the quality and regular supply of a coal to DESU during the current period of power crisis?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI BAIJ NATH KUREEL) (a) and (b) The coal supplied by the private coal suppliers was found in some cases to be below the prescribed specifications. This attracted the penalties laid down in the contract. The suppliers represented about these being very harsh. While this was under consideration of Delhi Electric Supply Undertaking, the coal suppliers unilaterally resorted to deferring/cancelling of the coal supplies. The DESU therefore, arranged with the National Coal Development Corporation and Bharat Coking Coal Ltd., to meet their coal requirements. This has been done as an emergent measure. As a result, coal supplies are now being received regularly and the coal stocks have been built up from about 2 days' requirements to about 15-18 days' requirements (40,000 tonnes). The coal available from the NCDC/BCCCL being of a different grade, the prices are not strictly comparable and the price adjustments offered by these undertakings are also different. Some deviations from specifications have been noticed in their supplies and the matter has been taken up with them.

FERTILIZER FACTORY IN PUNJAB
