- (b) A statement indicating the demands of funds so far received from the States for provision of house-sites to landless workers in rural areas is placed on the Table of the Sabha. [See Appendix LXXXI. Annexure No. 16]
- (c) Efforts are being made to accelerate the implementation of the Scheme so as to cover the whole country as early as possible, consistent with availability resources.
- (d) The whole programme may involve an estimated outlay of Rs. 300 crores for the country.

THE MINISTER OF WORKS AND HOUSING (SHRI UMA SHANKAR DIKSHIT): (a) to (c) There is no provision in the allotment rules for classification of general pool accommodation on the basis of their location. However, certain areas like D.I.Z. Area, Lodi Colony, Pandara Road, etc., are more popular than certain others like Motibagh, Ramakrishnapuram, Kidwai Nagar and Dev Nagar etc. based on the preference shown by applicants. Since it is not possible to meet all demands for accommodation in the more popular areas. in practice; allotments are made in the first instance in the comparatively less popular areas and allotments in the popular areas made subsequently depending on availability of vacancies and on the basis of a waiting list maintained of people desiring the change.
