- (d) The existing storage capacity (which is adequate to store the procured stocks) will be supplemented by construction of additional owned storage capacity through crash programmes of construction already in operation as also by making arrangements for cover and plinth storage. Arrangements also exist by which foodgrains are stored by FCI in the warehouses of the Central Warehousing Corporation and other agencies.
