(d) Some of the important measures adopted in this regard are :

Under special schemes formulated by Public Sector Banks advances are given by some banks upto a ceiling of Rs. 2 lakhs for individual entrepreneur and Rs. 3 lakhs in case of two or more entrepreneurs joining together for setting up of a small scale unit. Special relaxations are also provided during the initial years in terms of interest etc.

A Credit Guarantee Scheme has been instituted under which 75% of the loans up to specified limits are now re-imbursed to the banks by the Credit Guarantee Corporation of India Ltd. provided the loan is within specified ceilings.

Ministry of Industrial Development has provided an allocation of Rs. 3 crores for training of and assistance to engineer entrepreneurs.

In order to ensure that a young engineer, after he has gone through the course, is able to set up industrial enterprises of his own, State Governments have been requested to set up Coordination Committees so as to ensure that various problems relating to such facilities as water, power, land and premises, bank credit etc. are resolved expeditiously.
