JAL AIRCRAFT CRASHED NEAR DELHI

- (a) whether it is a fact that an aircraft belonging to JAL crashed near Delhi recently;
- (b) the number of people killed or injured in the crash and what assistance Government rendered to the victims;
- (c) whether the families of the persons killed have received any compensation from the Japan Airlines; if so, the details thereof;
 - (d) whether Government have set up

a court of inquiry to enquire into the causes of this aircrash; and

(e) If so, what are the findings?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH):
(a) Yes, Sir.

- (b) Out of the total of 89 persons on board, 86 were killed and there were only three survivors. In addition, 4 labourers working near the site of the crash were also killed. Relatives of the victims, who came to Delhi, were permitted to visit the site of the crash and were guided to the mortuary where the bodies had been kept for identification. The identified bodies were handed over to them in accordance with the procedures laid down in this regard. Survivors were also rendered all possible facilities.
- (c) The question of payment of compensation to the families of the persons killed as well as the amount of compensation to be paid is, it is understood, under consideration of Japan Airlines.
- (d) and (e) The accident is under investigation by a court of inquity presided over by a Judge of the Delhi High Court.

HIGHEST AND LOWEST SALARIED INCOMES

- (a) the highest and the lowest salaries being paid in the private sector; and
- (b) how do these compare with the highest and the lowest salaries paid in Government service?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRIMATI SUSHILA ROHATGI): (a) and (b) No authentic information is readily available regarding the highest and the lowest salaries being paid in the private sector. The highest appointment in the Central Government, viz., Secretary to the Government of India, at present carries a fixed pay of Rs. 4,900 per mensem officers and Rs. 3,500/ S. for L. C. per mensem for others. The lowest paid official under the Central Government gets total emoluments of Rs. 163 per mensem inclusive of dearness allowance and interim relief' In the absence of detailed information for the employees in the private sector in different pey ranges, no meaningful comparison is possibe.
