## DEVELOPMENT OF TOURIST PLACES IN HIMALAYAN AREA

**PURUSHOTTAM** 597. MISS SAROJ KHAPARDE: Will the Minister of TOUR-ISM AND CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that due to nonavialability of funds many a tourist places in the country especially near the snow lines in the Himalayan area are not being provided with bare minimum facilities for the tourists; and
- (b) if so, what steps Government propose to take in this direction?

THE MINSTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) and (b) Tourist facilities are being provided at places which are already popular with tourists or have the potential to attract tourists. Places which are near the snow line in the Himalayas, in many cases, lie beyond the "inner line" where movement is restricted. However, in the previous Plan periods funds had been provided for the improvement of Rest Houses/pilgrim sheds on the Kailash-Mansarovar route and along the Badrinath yatra route. In the current Plan, youth hostels are being constructed at Dalhousie, Darjeeling, Nainital and Patni Top, a Reception Centre is proposed at Simla, tourist facilities are being provided at Manali and a major winter sports cum summer resort is being developed at Gulmarg.
