- (2) Efforts are being made:
 - (i) to provide more bousing in the campus;

- (3) Steps have been taken to fill up vacant posts speedily.

(a) what is acreage of land irrigated by canals and by other private means in each State;

(b) how much of it is used as garden; and how much of it is barren; and

(c) how much barren land is reclaimed every year in each state?]

कृषि मंत्रालय में राज्य मंत्री (श्री अण्णासाहेब शिन्दे) : (क) वर्ष 1968-69 (अन्तिम वर्ष जिसके लिए अखिल भारतीय स्तर पर साधन-वार सिंचित आंकड़े उपलब्ध हैं) के लिए नहरों तथा अन्य साधनों से सिंचित क्षेत्रों के राज्य-वार आंकड़ों को प्रदर्शित करने वाला एक विवरण (संख्या 1) संलग्न है। (देखिए परिशिष्ट LXXXI, अनुपत्र सं० 39) भूमि उपयोगिता आंकड़ों के लिये अपनाया गया वर्तमान वर्गीकरण, नहरों द्वारा सिंचाई को छोड़कर, सरकारी तथा निजी साधनों से सिंचित भूमि के अलग-अलग आंकड़े प्रदर्शित नहीं करता है।

(ख) साधारणतः सिंचित क्षेत्र बंजर नहीं छोड़ा जाता है। फिर भी, वर्ष 1968-69 तथा 1969-70 के लिए (क) कृष्य बंजर भूमि, (ख) वर्तमान परती को छोड़कर परती-भूमि (ग) बंजर तथा अकृष्य भूमि के राज्यवार आंकड़ों को प्रदर्शित करने वाला एक विवरण (सं० 2) संलग्न है। (देखिए परिशिष्ट LXXXI अनुपत्र संख्या 40) बागवानी के अन्तर्गत क्षेत्र में संबंधित आंकड़े अलग से उपलब्ध नहीं हैं।

(ग) विभिन्न राज्यों में प्रति वर्ष कृष्यकृत बंजर भूमि के क्षेत्र से संबंधित जानकारी उपलब्ध नहीं है। फिर भी, चतुर्थ पंचवर्षीय योजना के अन्तर्गत विभिन्न राज्यों में अब तक कृष्यकृत क्षेत्र को प्रदर्शित करने वाला एक विवरण (सं० 3) संलग्न है। (देखिए परिशिष्ट LXXXI, अनुपत्र सं० 41)

†[THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI ANNASAHEB SHINDE): (a) A Statement (No. I) showing Statewise figures of areas irrigated by canals and other sources for the year 1968-69 (the latest year for which source-wise irrigated dale is available at the all India level) is attached. [See Appendix LXXXI, Annexure No. 39.] The present classification followed for the purpose of land utilisation data does not show the figures of

irrigated land separately for Government and private sources of irrigation except in respect of canal irrigation.

(b) Irrigated area is not normally left barren. However, a Statement (No. II) showing statewise figures of (a) culturable waste land, (b) fallow land other than Current fallows and (c) barren and uncul-lurable land for the years 1968-69 and 1969-70 is attached. [See Appendix LXXXI, Annexure No. 40.] Figures relating to area under gardens are not separately available.

(c) Information regarding area of barren land reclaimed annually in different States, is not available. However, a Statement (No. III) showing the area reclaimed so far during the Fourth Five Year Plan in different States, is attached. (See Appendix LXXXI, Annexure No. 41.)]
