

युक्त और विदेशी चिकित्सक संगठनों से प्राप्त सहायता से मे पूरा करती हैं। विभिन्न निम्नलिखित विस्थापित बस्तियाँ/शिबिरों में खोले गये अस्पतालों औषधालयों द्वारा रोगियों को उनके घरों पर ही इलाज कराने की सुविधाएँ दी जाती हैं। विस्थापितों के लिए संयुक्त राष्ट्र उच्चायुक्त और विश्व संगठन की वित्तीय एवं तकनीकी सहायता से तथा मेन्टल रूनिफ कमिटी (भारत) की सहायता से शय रोग नियंत्रण का एक व्यापक कार्यक्रम चलाया गया है जिसके अन्तर्गत बस्तियों और शिबिरों में रहने वाले सभी निम्नलिखित विस्थापितों को उपचार की सुविधाएँ दी जाती हैं।

(THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (DR. DEBIPRASAD CHATTOPADHYAYA): (a) Although no scientific survey has been conducted, it appears on the basis of data gathered during the visit of BCG Teams to certain settlements that the incidence of TB among the Tibetan Refugees is not higher than the incidence among the general population in India.

(b) The concerned State authorities have been requested to extend BCG Vaccination, tuberculosis case-finding and treatment facilities to Tibetan refugees residing in their respective States. The settlements which are situated in those districts where a district TB Centre has been established are looked after by such centres, as a part of their normal activity.

The Government of India have been meeting 50 per cent of the cost of the treatment of Tibetan refugees who are admitted in selected T.B. Sanatoria. Admission is arranged by the Central Relief Committee (India) and the other 50 per cent of the cost is paid by the Committee out of aid received from United Nations High Commissioner for Refugees and Foreign Voluntary Agencies. Domiciliary treatment is also given by the hospitals/dispensaries set up in the various Tibetan refugee settlements/camps. A comprehensive T.B. Control Programme covering all Tibetan Refugee Settlements and Camps has been initiated with financial

and technical aid from United Nations High Commissioner for Refugees and World Health Organisation and with the assistance of Central Relief Committee (India).]
