

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND IN THE DEPARTMENT OF PERSONNEL (SHRI RAM NIWAS MIRDHA): (a) Government have received representations regarding alleged atrocities on members of Scheduled Castes in Maharashtra State.

(b) and (c) According to information received from the Government of Maharashtra, on 14.5.1972, there was an incident in village Sonna, District Parbhani in which it was alleged that two women of Boudha community were forcibly stripped by some persons. A case under Section 354 of the Indian Penal Code was registered and all the three persons accused in the case were arrested. Investigation of the case is in progress.

#### † FORWARD TRADING IN GUR

220. SHRI SANAT KUMAR RAHA : Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state whether suspension of forward trading in 'gur' effective from October, 1972 has created any reaction among the rural gur manufacturers, and if so, what ?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOPMENT (PROF. SIDDHESHWAR PRASAD) : After suspension of forward trading in gur, in October, 1971 one recognised association forwarded some representations from rural gur manufacturers in the Maharashtra region pleading for resumption of forward trading in gur on the ground that such trading had benefited them by ensuring reasonable prices for gur.
