(a) and (b) On a request from the Government of Rajasthan in regard to the setting up a fertiliser plant in Rajasthan based on the rock-phosphates and pyrites deposits in the State, a Working Group was set up by the Government of India to look into the feasibility of setting up of a fertiliser complex in Rajashthan. The Working group has indicated the possibility of establishing such a complex in Rajasthan. Further action towards the establishment of the complex will be considered after the commercial exploitation of these deposits is established.
